- 8. The Renter must arrive and depart from the rented area by the prescribed time set out above in this Hall Rental Contract, and must use the area in a safe manner.

 9. The Renter consents and agrees to indemnify and save harmless the Glenora Community Association in respect to all
- claims, demands, actions, suits and costs arising out of any act or omission of the Renter and/or servant, agent or employee of the Renter or arising out of the use of the said facility by the Renter.
- 10. The Management reserves the right to cancel or alter the rental should conditions arise which necessitate schedule changes.
- 11. Out of respect for our neighbours, music must be shut down by 1:00 a.m.
- 12. The Renter must provide all insurances and permits as needed
- 13. No decorations are to be placed on the entrance walls of the bathroom hallway.
- 14. When decorating the main hall, the Renter may only put tacks in the 1"x4" trim which runs around the hall at the 4-foot level and/or on the trim which is at the 10-foot level.
- 15. All decorations must be approved by the Rental Committee. No hay bales, rocks, branches, soil, etc. are allowed in
